Delivery of the service is required for **One Hundred Twenty (120) Calendar Days** upon receipt of the Notice to Proceed. Bidders should have completed, within *two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary **"pass/fail"** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from **SDO Iriga City BAC Secretariat** and inspect the Bidding Documents at the address given below during **Monday to Friday, 8:00 am to 5:00 pm**.
- A complete set of Bidding Documents may be acquired by interested Bidders on **May 8, 2025** until **May 27, 2025** from the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P5,000.00) Only to the DepEd, Iriga City Division, Cashier Office**.
