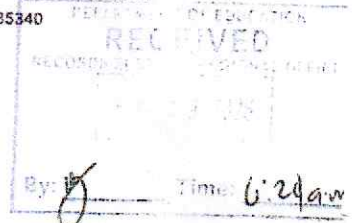

Subject: Request for Support and Endorsement for Organization of Philippine Alliance of Retired Educators Regional Chapters through Regional Memorandum to Schools Division Superintendents

Dear RD Sadsad:

On behalf of the Philippine Alliance of Retired Educators (PARE), a nationwide association of retired DepEd personnel dedicated to mentoring, volunteer service, and advocacy for retirees' welfare, we respectfully request your support to organize PARE chapters in the Schools Divisions under your jurisdiction.

We ask that your office issue a Regional Memorandum to Schools Division Superintendents endorsing chapter formation and designating a Division focal person to assist outreach and coordination. PARE chapters will support DepEd programs through mentoring, literacy and remedial initiatives, school improvement volunteer work, and welfare activities for retired educators. To facilitate the successful organization of PARE chapters, we respectfully propose the following actions:

1. Issue a Regional Memorandum to Schools Division Superintendents endorsing the organization of PARE chapters and encouraging Division Offices to assist in outreach to retired education personnel.
2. Designate a Division Office focal person in each Schools Division Office to coordinate chapter formation and to serve as the official point of contact.
3. Authorize Dr. Maria Celia Fernandez to meet with Division Superintendents to present PARE's objectives, organizational requirements, and support needs. Ms. Fernandez is authorized to discuss and coordinate chapter organization on behalf of PARE.
4. Encourage Division Offices to schedule initial information meetings with retired educators, to identify interested officers, and to submit names and contact details to the Regional Office and to Dr. Fernandez for follow-up.
5. Provide a copy of the Regional Memorandum and a list of Division focal persons to PARE for coordination and record-keeping.

Please be advised that Dr. Maria Celia Fernandez, Vice President for Luzon is authorized to discuss and coordinate the organization of PARE chapters with your office and with Division Superintendents. Ms. Fernandez can provide the necessary background materials, a sample chapter constitution and by-laws, membership forms, and a suggested timeline for organizing chapters.
