1. In reference to **Regional Memorandum No. 00689, s. 2026** re: **Advisory No. 5 to RM 00345, s. 2026 - Regional Training of Teachers on the Revised ALS Curriculum** dated 19 March 2026, the Schools Division Office of Iriga City, through the Curriculum Implementation Division (CID), announces the assigned participants for the said activity, which aims to capacitate ALS teachers in designing and delivering learning sessions aligned with the Revised K to 12 Curriculum, responsiveness to learner context, and the use of localized instruction and appropriate assessment tools.
2. The training will be conducted in two batches (Batch 3 & 4) at Coastal View Resort, Calayucay, Sto. Domingo, Albay.
3. The official list of participants for each batch is provided in Enclosure No. 1 of this Memorandum and is arranged accordingly by schedule. All identified participants are directed to attend on their respective schedules.
4. Consistent with Civil Service Commission (CSC) rules and DepEd guidelines, ALS teachers shall be entitled to vacation service credits for services rendered, considering that this activity is conducted during summer break. Non-teaching personnel who will render services on weekends shall be entitled to Compensatory Overtime Credits (COC), which may be availed of as compensatory time off.
5. Travel and incidental expenses of the participants shall be chargeable against the downloaded Program Support Funds (PSF) for FLO ALS or local funds, subject to the usual government accounting and auditing rules and regulations.
6. This memorandum shall also serve as authority to travel for each participant, whose list is arranged by batch and scheduled on separate dates.
7. Immediae dissemination of this memorandum is desired.
