CONDUCT OF THE REGIONAL LEARNER RIGHTS AND PROTECTION (LRP)
SPECIALIZATION COURSE

1. The Learner Rights and Protection Specialization Course (formerly the *Child Protection Specialization Course*) is a training program initiated by the Learner Rights and Protection Division (LRPD) which aims to equip our educators and DepEd personnel with knowledge and skills to effectively address learner rights and protection concerns, strengthen our preventive and responsive approach, and ensure the well-being and protection of our learners' rights. With this, DepEd Region V will conduct the Regional Learner Rights and Protection (LRP) Specialization Course on September 21-24, 2026, at Masbate City.
2. At the end of the LRP Specialization Course, participants are expected to:
 - a. Explain the principles of learner rights and protection including relevant DepEd policies, laws and guidelines.
 - b. Identify learner rights and protection concerns and determine appropriate preventive and responsive interventions
 - c. Apply established protocols for reporting, referral, case management and documentation while ensuring confidentiality and the best interests of the learner.
 - d. Promote safe, inclusive, gender-responsive and learner-friendly school environments through positive discipline and child-sensitive practices.
 - e. Develop and implement school-based strategies and action plans that strengthen learner rights and protection and foster collaboration with parents, communities, and partner agencies.
