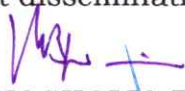

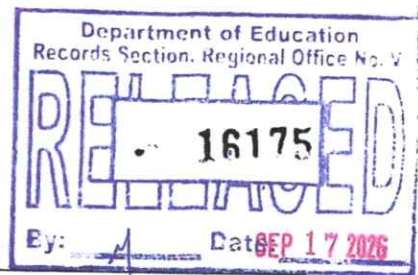

Contest Guidelines:

Participation and Team Composition	The competition is open to public school learners from Grade 7 to Senior High School (Grade 12). Each participating team shall come from one (1) school and shall be composed of: four (4) officially enrolled learners for School Year 2026–2027; and one (1) teacher-adviser, who shall guide the learners and ensure their safety throughout the creation of the parol. Each Schools Division Office shall endorse one (1) official parol entry to represent the Division in the National Parol Competition. The learners shall take the lead in the conceptualization, design, and construction of the entry.
Design and Material Requirements	Each parol entry shall: - Reflect the official competition theme; - Incorporate Filipino identity, values, and traditions; - Promote peace, healing, unity, and hope; - Demonstrate originality and creativity; and - Be structurally stable and safe. The official size of the parol shall be two (2) feet in diameter, with approximately 35% of the diameter in thickness at its core. No stand shall be included. A parol tail is allowed but shall not exceed two (2) feet in length. The tail shall not be included in determining the required diameter. Entries shall be strictly measured upon submission. Entries that exceed or fall below the prescribed dimensions shall be subject to the corresponding point deductions under the official competition rules. Participants are strongly encouraged to use indigenous, recycled, sustainable, and/or locally sourced materials. The use of environmentally harmful materials is discouraged. The use of plastic is strictly prohibited, and entries incorporating plastic materials may be disqualified. Each parol must incorporate lighting. LED lights, solar-powered lighting, and other energy-efficient illumination may be used.

	Open flames are strictly prohibited, and all electrical components must be properly installed and safe for use under varying weather conditions. Commercially manufactured or ready-made parols are strictly prohibited. The organizing team shall verify that the entries were actually created by the participating learners through the required video documentation.
Documentary Requirements	Each official Division entry shall be accompanied by an official endorsement letter officially signed (wet or electronic) by the Schools Division Superintendent, addressed to the following: Sec. Bianca Cristina C. Zobel Social Secretary Office of the President Thru: Dir. Vivian C. Recio Director for Events and Production The endorsement letter shall indicate the following: - Names of the four (4) officially enrolled learner participants; - Name of the school represented; and - Other pertinent information required under the official competition guidelines. The original/printed and soft copies of the official endorsement letter shall be submitted together with the actual parol entry. Entries without the required endorsement letter shall not be accepted. Participating schools shall likewise submit a brief description of the parol entry, including: - The materials used; - The inspiration and concept behind the design; and - The names of the learners who created the entry. A video documentation of the parol-making process shall also be submitted as proof that the entry was conceptualized

	and created by the participating learners. The video shall conform to the following specifications: • Orientation: Landscape • Maximum duration: 1 minute and 30 seconds • Content: Wrap-up documentation of the parol-making process • Device: Mobile phone camera or SLR • Submission: Flash Drive/USB or Google Drive • Google Drive submissions shall be sent to sosec_events@op.gov.ph The files inside the flash drive/USB or Google Drive are the following: • Video documentation of the creation process • Soft copy of the endorsement letter • Brief description of the parol entry The video documentation shall serve as proof that the learners created the entries and shall be utilized during the parol judging and presentation. Participating Schools Division Offices are therefore advised to ensure that the video clearly demonstrates the learners' participation in the conceptualization and construction of the entry.
Grounds for Disqualification	Entries shall be subject to the official grounds for disqualification, including, but not limited to: a. Non-compliance with the prescribed size requirements; b. Use of hazardous or unsafe materials; c. Use of open flames or unsafe electrical wiring; d. Plagiarism or direct copying of another design; e. Submission of more than one official entry per school/Division, as applicable; f. Failure to submit the required documentation and other requirements; and g. Failure to submit the entry within the prescribed deadline.
Judging Criteria	Entries shall be evaluated based on the following criteria: <u>Relevance to the theme (30%)</u> • The entry clearly communicates the theme "<i>Kabataang Pilipino: Tanglaw ng Pag-asa</i>" • Judges shall consider: ◦ Clear message of hope;

	- o Promotion of peace; - o Positive role of the youth; and - o Inspiration and emotional impact. <u>Creativity & Originality (25%)</u> • The uniqueness of the concept and artistic interpretation. • Judges shall evaluate: - o Original design; - o Innovative use of materials; - o Creative storytelling; and - o Distinct artistic identity. <u>Craftmanship & Technical Excellence (20%)</u> • Quality of construction and execution • Judges shall consider: - o Precision; - o Durability; - o Structural integrity; - o Quality of lighting effects; and - o Overall presentation. <u>Cultural Identity & Symbolism (15%)</u> • Effective integration of Filipino Heritage • Judges shall assess: - o Representation of Filipino traditions; - o Cultural authenticity; - o Meaningful symbolism; and - o Respect for local identity. <u>Online Poll (10%)</u> • This criterion recognizes public engagement and appreciation through online voting conducted via the official competition website. It encourages schools to promote their entries responsibly while fostering nationwide participation in celebrating Filipino creativity and culture. • Photos of each official entry will be uploaded in a website. Supporters can click the link to the website that will be posted in the official Facebook account of the Social Secretary's Office. • The school with the highest online vote will automatically get the 10% in their scorecard and will win the online vote award. • Online voting will end on November 18, 2026, 12:00 pm. The website will automatically close on the stated deadline.

Annex A. Frequently Asked Questions (FAQs) from the Social Secretary's Office.

DO WE SEND THE OFFICIAL ENTRY TO MALACAÑANG?

YES. All official parol entries are to be sent to Malacañang.

WHO WILL PAY FOR THE MATERIALS IN CREATING THE PAROL?

Learners and the school can collaborate. We understand that there is monetary part involved that is why this competition is voluntary and not required.

WHO WILL ARRANGE FOR THE ENTRIES TO BE SENT TO MALACAÑANG?

The Division Office and the school should arrange for this. From previous years, they usually send it through courier and all the requirements are sent together with the actual parol entry.

CAN THE COORDINATORS BE INVITED TO THE AWARDING?

Here's who will receive an official invite to the awarding:

4 Learners + 1 School representative

- a. Airfare/bus fare;
- b. Meals and accommodation during their stay;
- c. Vehicle service from the airport to the hotel, Malacañang, and back to the airport; and
- d. Certificates of appearance for the learners and school representatives.

1 Division Representative (Division Superintendent or whoever he/she appoints).
Invite only. No plus one.

CAN TWO SCHOOLS COLLABORATE FROM THE SAME DIVISION AND SEND ONE ENTRY?

NO. One entry per school per division. Learners from different schools in the same division or different division is also not allowed to collaborate.

CAN A COACH / TEACHER HELP IN THE CREATION OF THE PAROL?

YES. They can provide assistance but the LEAD CREATOR are the learners. Learners are in charge of the conceptualization and creation. Teacher/coach is there to assist and ensure safety of the learners while constructing the parol.

WILL THERE BE A DIVISION LEVEL ELIMINATION?

IT IS UP TO THE DIVISION OFFICE. We leave it up to the Division Office on how they will select their official representative to the National Competition. They can organize a division wide competition and base their guidelines and criterias on the National competition. If they do so, they are to provide the Division level prizes.

ARE THE LEARNERS REQUIRED TO APPEAR IN MALACANANG DURING PAROL SUBMISSION OR JUDGING?

NO. Learners are not required during entry submission or parol judging. Only our team and judges are present during the judging.

IS THERE A CONSOLATION PRIZE TO THOSE WHO PARTICIPATED?

Only the Top 3 winning schools, learners and Division will receive the major prizes. Also, the winners of the special awards: Online voting, Most Innovative Lighting Design, and Best in Cultural Interpretation.

CAN THE WINNING SCHOOLS FROM YEAR 3 STILL PARTICIPATE?

YES. As long as participating learners for this year's entry is different from when they won.

CAN YOU PROVIDE A CERTIFICATE OF PARTICIPATION FOR THOSE WHO JOINED?

YES. We can provide a digital copy of the certificate to the following:

- Learners who participated
- School

Note: For the certificate of the participation, it is the name of the School that will appear in the certificate not the name of the Principal, coach, or the teacher.

I WAS INVITED BY DEPED TO ATTEND THE CHRISTMAS TREE LIGHTING. CAN YOU PROVIDE THE CERTIFICATE OF APPEARANCE?

NO. You should request it from DepEd. The only group that we can provide are the following:

- 4 Learners + 1 School representative
- 1 Division Representative
- Representative/s who went to the palace to submit the parol entry.

DepEd will have invited guests to the tree lighting ceremony. It is up to them who they will invite. Those invited by DepEd, you can request your certificate of appearance from them.
